#### THE CHAIRMAN OF ANDOVER TOWN COUNCIL

This is a meeting where, as Chairman, I report back to Andover Electors on the work that the Town Council has done during the last year. However, on this occasion I will be supported by the Chairman of the two committees, who will give a report on the workings of their team.

This has been a very special year for the Town Council as it has been the first year of its existence. After three years of campaigning the Town Council was declared on 1<sup>st</sup> April 2010. The Town Council has worked hard this year to put in place the statutory requirements in order that it is run within the law. It appointed a new Town Clerk in December 2010 and 2011/2012 looks to be a very exciting year with the prospect of a new website, the transfer of Allotments and Christmas Lights.

The Town Council works on the principle of one team, this team consists of 19 elected members (Councillors) who agree policy, give direction and are locally accountable. The other part of the team is the Town Clerk who delivers the projects on the ground, as you will see from the performance chart and the reports from the Chairmen.

The reports you hear tonight will clearly inform you of everything the Town Council and its Clerk have delivered.

Finally I wish to thank my fellow Councillors who work tirelessly without pay of expenses to represent the Council by taking residents' calls and concerns at their homes, representing the Council on Outside Bodies and promoting the quality of life demanded by the residents of Andover.

#### INTRODUCTION

#### **The History of Andover Town Council**

Before 1974 the Andover Borough Council was the local and district body that was responsible for the five wards of Andover, which included also Charlton and Enham Alamein Villages.

In 1974 the Andover Borough Council was disbanded and Test Valley District Council took over all its assets and responsibilities. From 1974 until 1976 Andover had Andover Charter Trustees, which appointed their own Town Mayor from amongst their Councillors.

In 1976 Test Valley District Council applied to the Queen to become a Borough and the Queen's Privy Council granted it Borough status later that year and the Charter Trustees were dissolved.

Under the regulations existing at the time, Andover was prevented from applying to have parish status as the limiting factor was a population of 20,000 and Andover's population was about 38,000.

It was not until the regulations changed that Andover was able to make an application for government review to be considered for parish status.

Following two previously unsuccessful campaigns to apply for parish status, a new campaign began in late 2007 which lasted three years, to get the required number of electors to petition Test Valley Borough Council to begin proceedings for a governmental electoral review.

The new council was officially declared by Test Valley Borough Council on 1<sup>st</sup> April 2010. Elections were held in May and the new Council, comprising of 19 elected Members started officially on 26<sup>th</sup> May 2010.

The Council was formed from nineteen elected members representing five wards in the Parish of Andover. In June 2010 the Parish Council of Andover resolved that henceforth it would be referred to as Andover Town Council.

In 2010 the Town Council agreed to use the badge of Andover, in use since 1599, as its official logo.

The first Chairman of Andover Town Council was Anthony Raper.

The Town Council is composed of 19 members (Councillors) representing the 5 wards (Alamein, Harroway, Millway, St Mary's and Winton) in the Town of Andover. All Councillors were elected by the people of the town in a single election in May 2010 but their first term has been extended to 5 years in order to coincide with the Test Valley Borough Council local government elections.

The Chairman hold office from the election of Chairman ceremony of one year the Annual Town Council Meeting, generally held in May, until the ceremony of the following year. The

Chairman has the opportunity to promote and uphold the character of Andover as well as preside over meetings of Full Council.

#### **Demographics for the Town Council**

Andover Town Council covers an area of 5248 Acres.

The total population of the Andover area is approximately 38,000.

The area consists of five wards represented by Councillors as follows:

Alamein – 3 Councillors

Harroway – 4 Councillors

Millway – 4 Councillors

St Mary's – 4 Councillors

Winton – 4 Councillors

#### THE COUNCIL

The Town Council was formed in 2010 under the powers of the Local Government Act 1972.

#### The Powers and Duties of the Town Council

Andover Town Council has limited powers and duties as a town council. Listed at **Appendix A** are the powers and duties of Andover Town Council.

#### **Best Value Principles**

The Local Government Act 1999 placed a new duty of Best Value on local authorities. However Town and Parish Council's have a duty to adopt the principles of best value in considering how it delivers its services.

Best Value is about delivering commitments for service responsiveness, efficiency, effectiveness and accessibility at the local level in order to make life better for people and for business. The Town Council recognises that Best Value is more than a periodic challenge. They recognise its' potential for delivering substantial change and delivering real improvements and although the Town Council is not legally required to implement a Best Value regime, it has adopted the principles of Best Value.

#### **Partnerships**

The Town Council hopes to work in partnership with many organisations in Andover. It has started working with Andover Vision to help and support the Christmas Lights Switch On Event and has been working closely with Test Valley Borough Council for the smooth handover of Allotments and Christmas Lights. The Town Council hopes to work closely with many other organisations.

The Town Council has started a Grants Funding Scheme, where grants will be awarded to local organisations that benefit the local people.

#### **ELECTED COUNCILLORS**

A list of the elected Councillors and the wards of Andover that they represent can be found at **Appendix B**.

#### **Code of Conduct**

Andover Town Council adopted its' Code of Conduct on 9 June 2010. It sets out the conduct that is expected of Members of the Council. All Members have registered their financial and other interests as required by the Code of Conduct and will register gifts and hospitality in excess of £25 they receive as Members. The public can inspect the Code of Conduct, the Register of Interests, and the Register of Gifts and Hospitality by making an appointment with the Town Clerk.

The Code requires Councillors to declare personal interests in items considered by the Council and if that interests considered to be prejudicial, Councillors are required to remove themselves from any vote on the matter.

#### **Committee Structure**

Andover Town Council holds nine Full Council meetings a year, including the 'Chairman Making or Annual Town Council' meeting held in May. The Chairman of the Council presides as Chairman over Full Council with the Vice-Chairman of the Council acting as Vice-Chairman of the meetings.

There are currently two main Committees which feed into the Full Council; these are the Policy and Resources Committee and the Planning Committee.

The Policy and Resources Committee meets eight times a year, before Council and the Planning Committee meets twice a month.

The Town Council also has a Sub-Committee for Allotments and four Working Groups for Assets, Grants, Christmas Lights and the Website. These are time limited Groups and once they have completed specific tasks they will be disbanded and their services will be monitored by Policy and Resources Committee or Full Council.

At **Appendix C** is a diagram of the Committee Structure.

Each committee has a Chairman and Vice-Chairman. The Policy and Resources Committee has eleven Members and the Planning Committee has eight Members.

#### **CONSULTATION AND FEEDBACK**

#### **Council and Committee Meetings**

Andover Town Council holds nine Council Meetings a year. Members of the public are entitled to attend these meetings and at the beginning of the meeting, the Chairman will ask if any members of the public would like to ask the Council a question.

Andover Town Council also has two Committees. Policy and Resources Committee is held eight times a year and Planning Committee is held twice a month. Members of the public are entitled to attend all the Committee Meetings usually at item 4 on the agenda, members of the public are invited to make a statement about any item appearing on the agenda.

#### Website

Andover Town Council is researching and putting together options for a website that is anticipated to 'go live' during 2011. The website will be full of local information for the people of Andover.

The Website will provide information about forthcoming meetings of the Town Council, current agendas and minutes will also be available.

The Website will also provide links to other websites with local information such as Andover Sound and Andover Vision.

#### **Annual Town Electors Meeting**

Each year the Town Council has a duty to hold a meeting for the electors of Andover.

It is an opportunity for local people to find out what the Town Council has achieved over the past year and to provide feedback to the Council on issues that they feel are important and that the Town Council should be doing something about.

Even if the Town Council does not have the power to act upon an issue, it can often take the issue to the right authority or the Council will know the 'right people' to talk to.

#### **Town Councillors**

The current Council (19 Members in a total of five wards) was elected in May 2010 and will serve for a five year term. The next elections will take place in May 2015. Historically elections have always been fought and there is a history of active civic involvement in the town that is considered to be healthy for effective democracy. All Andover Town Councillors are unpaid and have elected to receive no allowances or expenses even though they show huge commitment in fulfilling their democratic responsibilities and mandate.

The Town Council elects a Chairman from its own membership each year along with a Vice-Chairman at the Annual Town Council meeting in May of each year.

#### **Staffing**

Currently Andover Town Council has one full time member of staff, the Town Clerk Miss Wendy Coulter.

#### Report of the Chairman - Cllr Philip North

#### **Background**

After the first elections for Andover Town Council in May 2010 one of the first actions of Andover Town Council was to set up a Policy & Resources committee. It is this committee that is the real work house of the Andover Town Council. It provides 5 main functions;

- 1) It introduces Policy which is then referred to the Full Council for ratification.
- 2) It reviews Policy that has been introduced at the Full Council and assesses its viability before ratification by Full Council.
- 3) It identifies the resources of the Council and puts together the Annual Budget which is presented to Full Council for agreement.
- 4) It investigates what is required for the running of services and carries out the day to day running of those services through its sub-committee and working groups.
- 5) It is responsible for managing the Council's Corporate Governance and Risk Management.

The Policy & Resources Committee is made up of 11 Councillors whose membership reflects the Political Balance of the Council. There are 5 Conservatives, 3 Lib Dems and 3 Independents. The Committee currently has one sub committees and three working groups, one of which is permanent; the Allotments Sub-Committee and three adhoc working groups; the Christmas Lights Group, the Website and Communications Group and the Assets Group.

#### The Work of the Policy and Resources Committee

The main piece of work undertaken by the Policy & Resources Committee this year was to put together the first ever budget of the properly constituted Town Council. Thanks to the committees' careful planning we proposed a freeze on the Town Council Precept.

The Town Council is funded solely by its residents through the Town Council's Precept. Contrary to many misunderstandings the Council is not funded by Central Government or through local Business Rates. It is therefore important, we believe, that we have a financial policy which is both prudent and focused, on how the Town Council's resources are managed.

In the coming financial year (1st April 2011 to 31st March 2012) the Council has agreed a Precept of £130,545.

As the Andover Town Council becomes responsible, from April, for the allotments, the Andover Levy that is levied by TVBC will be reduced to reflect this. The Andover Levy has been adjusted downwards to £24.03 per Band D equivalent down from £25.24 last year. Therefore because the Town Council and the County Council are also freezing their Council Tax – Andover residents will see a decrease of £1.21 in the local authority element of the Council Tax.

Due to our prudence this year it was also possible to allocate a significant amount from this year's budget to our reserves, which means we are complying with audit requirements and have some money set aside for a contingency. This money is not being hoarded, indeed we used some of the underspend from this year to fund the tax freeze for 2011/12 but it ensures we are on a stable financial footing.

It is the Committees' aim to steadily decrease the Andover Special Expenses Levy, by taking over services and running them in an efficient and effective way. It is this ambition that the Assets Working Group are investigating. Through the taking over of the Allotments we are clearly making good progress in our goal of reducing this levy. The Allotments Sub-Committee is confident significant savings in the costs of administration can be made and through the budget the Policy & Resources Committee proposed no increase in the allotment charges for the coming year. The Allotments Sub-Committee is currently working with allotment associations and allotment holders to establish the processes and procedures for running the allotments. The Sub-Committee feels it is important to work with Allotment holders in doing this as decisions should be taken as close as possible to the people they affect.

Following the Policy & Resources meeting on the 24<sup>th</sup> February it was agreed to refer to Full Council the recommendation to set up a Website & Communications Working Group to put together the Councils website and to come up with a variety of ways of how we consult with the public.

#### Conclusion

In short it has been a solid first year for the P & R Committee – we have ensured that the Town Council is on a stable financial footing and we are getting on with the job of providing efficient & effective services.

#### Report of the Chairman - Cllr Alan Cotter

#### **Background**

Andover Town Council's Planning Committee has the job of making observations on the Planning Applications for Andover submitted to the Planning Authority, Test Valley Borough Council.

Andover Town Council does not have the power to make any decisions on Planning matters, but it is entitled to be consulted. Each week the Town Council receives copies of Planning Applications that have been made to Test Valley Borough Council and meets twice a month to make observations about the planning applications.

The observations of the Committee are then forwarded on to the Planning Authority for consideration when they are making a decision about whether or not to grant planning permission.

#### The Work of the Planning Committee

#### Planning Applications considered

During 2010/2011 the Planning Committee has made observations on 198 Planning Applications with 16 of those being objections.

#### Consultation and Representation

Andover Town Council is regularly consulted on a wide variety of plans and proposals by Borough, County and regional and national government. The Planning Committee has recently considered a Consultation from Test Valley Borough Council on the Local Development Framework – Sustainability Appraisal.

In February 2011 the Planning Committee appointed Cllr Long to represent the views of the Town Council on a number of planning applications being considered at a Test Valley Borough Council Planning Committee.

#### **Conclusion**

The Planning Committee meets every two weeks and has worked hard this year to make informed and reasonable observations on all the Planning Applications it has considered. With the current economic climate building trends are changing and the Planning Committee will endeavour to keep abreast of all the changes that are happening in Andover.

The Town Council is seeking to be proactive in supporting the view to reduce garden grabbing and has raised this issue with the Borough Council and will continue to challenge overdevelopment and infill development.


