At the February 8, 2023, Full Council meeting the installation the extension to the Christmas Lights provision was approved.



	Councillor R Rowles gave his thanks to the Officers and Working Group for their hard			
	work with the Christmas Lights.			
	It was proposed by Councillor D Coole and seconded by Councillor R Rowles that all the			
	recommendations as stated in the agenda, be accepted.			
	A vote was taken which was unanimous. RESOLVED: That:			
	• The proposed extension be approved.			
	• The cost of the installation of the commando sockets to be taken from the			
	<u>CiL funds be approved.</u>			
	• That the proposed timeline was the best case scenario and left no time allowance for overrun or problems that may occur, be noted.			
	• The Officers' recommendation that the 1 year extension is accepted, to ensure that Andover Town Council are able to provide Christmas Lights provision for 2023.			
	• Officers be delegated to explore the possibility of additional lights with current provider, IF commando sockets and structural survey is completed, in time to apply for licenses.			
	• It be noted that the delivery of any extension to the scheme is subject to the vagaries of external suppliers for example, SSE. Therefore, it is recommended that ATC accept the extension to allow for delivery of the same or better Christmas Light provision in 2023.			
	• The increase cost when proposing the Budget 2023/2024 to Full Council, be accommodated




London Street and Winchester Street:




Bridge Street and Lower High Street



Town Mills extension:




High Street - Lower and Higher




The approved extension consists of 20 more columns:


George Yard Car Park – 10 columns

Waterloo Court – 4 columns.




To get the commando sockets installed on the 20 new columns has been quoted as **£304 per** column (Total = £6080, an updated quote has been requested so there may be a slight increase).

It was approved in the Full Council meeting of 8 February 2023 that this cost would come from CiL money.

Further Considerations:

Officers would like Council to consider adding to the approved extension to include a further 31 columns along the Western Avenue. This would have a huge impact on those approaching the Town Centre, and the major surrounding roads of the Town Centre and the Town Centre itself would then be completely lit.
