No assessment of the potential impact upon the town centre of Andover has been carried out in support of the application, and it is not known whether the development would result in harm to the vitality and viability of the Andover town centre, contrary to the provisions of policies LE10 and LE11 of the Test Valley Borough Revised Local Plan (2016).
