Summary of Key Issues

To receive and review requests for additional locations for SID placements.

Background:

Additional SID locations for Vigo Road and River Way were discussed at the Planning meeting of 29 August 2023.

Vigo Road: It was agreed that the suggested sites on Vigo Road were to be objected to, on the grounds that the sites would not allow for sufficient forward visibility, in accordance with the Hampshire Highways SID Policy and Guidance. Alternative sites further along Vigo Road are to be investigated.

River Way: It was agreed that the first site would be suitable, however, a site further away from the school would be preferable, to allow for the required forward visibility distance.

Additional positions for consideration:

Picket Piece: Whilst the issue of the hedge around LC33 is being resolved, the maintenance contractor has recommended two alternative sites as below:

1st link: https://maps.app.goo.gl/E2z44xVq2T8aZGu57

There would be a need to install a post towards the rear of the footway just to the west, between the next two properties along. Which would need permission, installation and would incur further cost.

Further consideration is that the SID would need to have a vertical clearance of 2.1m, so the side of the sign may be visible from the two properties that may not be welcomed.

Permission would be needed for the SID Operator to park in the wide access to the west or the access opposite.

The vertical clearance now, is 2.3m below the bus stop flag, so an extension post would be required as it's adjacent to a footway.

Meanwhile, Picket Piece has been temporarily removed from the rota until the situation is resolved.

This is an urgent matter as the Walworth Road entrance into Picket Piece is the most accident-prone end with a high level of Health and Safety risk to pedestrians, particularly due to no provision of a footpath where the school children await the school bus.

Anton Road: A request has been received from a Member of the Public, to consider a location in Anton Road, after a vehicle crash and the proximity to the junior school.

Potential locations have been indicated on the attached maps for Vigo Road and River Way.

The Avenue: A request has been received to which Officers are currently awaiting a response, as to the required location along The Avenue.

Potential locations have been indicated on the attached maps for Picket Piece and Anton Road.

Limitations for locations are:

- Speed limit must be 40 mph or under for any location considered.
- Single lane for any location considered.

- Consideration in terms of light pollution needs to be taken for any private dwellings nearby any proposed location.
- SID forward visibility 20mph speed limit is a minimum of 60m, 30mph speed limit is a minimum of 90m and 40mph is a minimum of 120m.
- The site must be inside the speed limit and the SID is not to be placed upon the entry sign to the speed limit.

Legal and Policy Implications

• Andover Town Council has the power to purchase and install traffic calming measures.

Recommendations

- To receive and note the report.
- To advise Officers on next best steps for the Picket Piece and Anton Road locations.
