The Council is undertaking public consultation on its updated draft Infrastructure and Developer Contributions Supplementary Planning Document (SPD). Consultation will commence on Friday 4th November 2022 for a period of 6 weeks ending 12noon Friday 16th December 2022.

The purpose of the SPD is to set out the Council's approach to using planning obligations for local residents, developers and the wider community; explain the circumstances under which the Council will collect Section 106 contributions to mitigate the impacts of a development on infrastructure; set out the standard required for some types of infrastructure; and provide applicants with greater certainty on when planning obligations will be sought.

Cornerstone are in the process of progressing suitable sites in the Andover area to improve service provision and have identified this site as suitable for an equipment upgrade for Cornerstone.

Mobiles can only work with a network of base stations in place where people want to use their mobile phones or other wireless devices. Without base stations, the mobile phones, and other devices we rely on simply won't work.

Please find below the details of the proposed site: -

Our technical network requirement is as follows:

- Cornerstone 13139223 (Cornerstone) at Western Avenue SW.
- There is a specific requirement for a radio base station upgrade at this location to provide improved technical provisions, greater capacity and coverage in the area.

A number of options have been assessed in respect of the site search process and we consider the best solution is as follows:

- Western Avenue SW, Western Avenue, Land Adj Folly Roundabout, Andover, Hampshire, SP10 3PX, NGR: E: 436004 N: 146066.
- Proposed upgrade: Existing 17.5M High Hutchinson Jupiter Dual Stack Monopole to be removed and replaced with proposed 20.0m Heavy A12RV2 Apollo Pole to be installed on new T9 root foundation. Proposed 6No. Antennas, 1No 300Ømm Dish,1No. GPS Module and 1No. Cabinet c/w sidepod to be installed. Existing Cabinets to be refreshed internally and associated ancillary works. For full details please refer to the enclosed drawings.

The Local Planning Authority mast register and our records of other potential sites have already been reviewed, the policies in the Development Plan have been taken into account and the planning history of the site has been examined.

All Cornerstone installations are designed to be fully compliant with the public exposure guidelines established by the International Commission on Non-Ionizing Radiation Protection (ICNIRP). These guidelines have the support of UK Government, the European Union and they also have the formal backing of the World Health Organisation. A certificate of ICNIRP compliance will be included within the planning submission.

Hampshire County Council and its partner Authorities, Southampton City Council, Portsmouth City Council, New Forest National Park Authority and South Downs National Park Authority – are working to produce a partial update to the Hampshire Minerals and Waste Plan up until 2040.

The partial update to the Plan will build upon the currently adopted Hampshire Minerals and Waste Plan (2013), with an updated evidence base on how much minerals the area needs and how much waste it produces, now and up to 2040.
