I have received an application for a new Pavement Licence from Jason Wyatt for the pavement immediately outside of the following premises:

The Ark Bar, 43 London Street, Andover SP10 2NU

This is an application for a new Pavement Licence issued under the Business and Planning Act 2020. The location of the area to be licensed is shown on the attached plans. 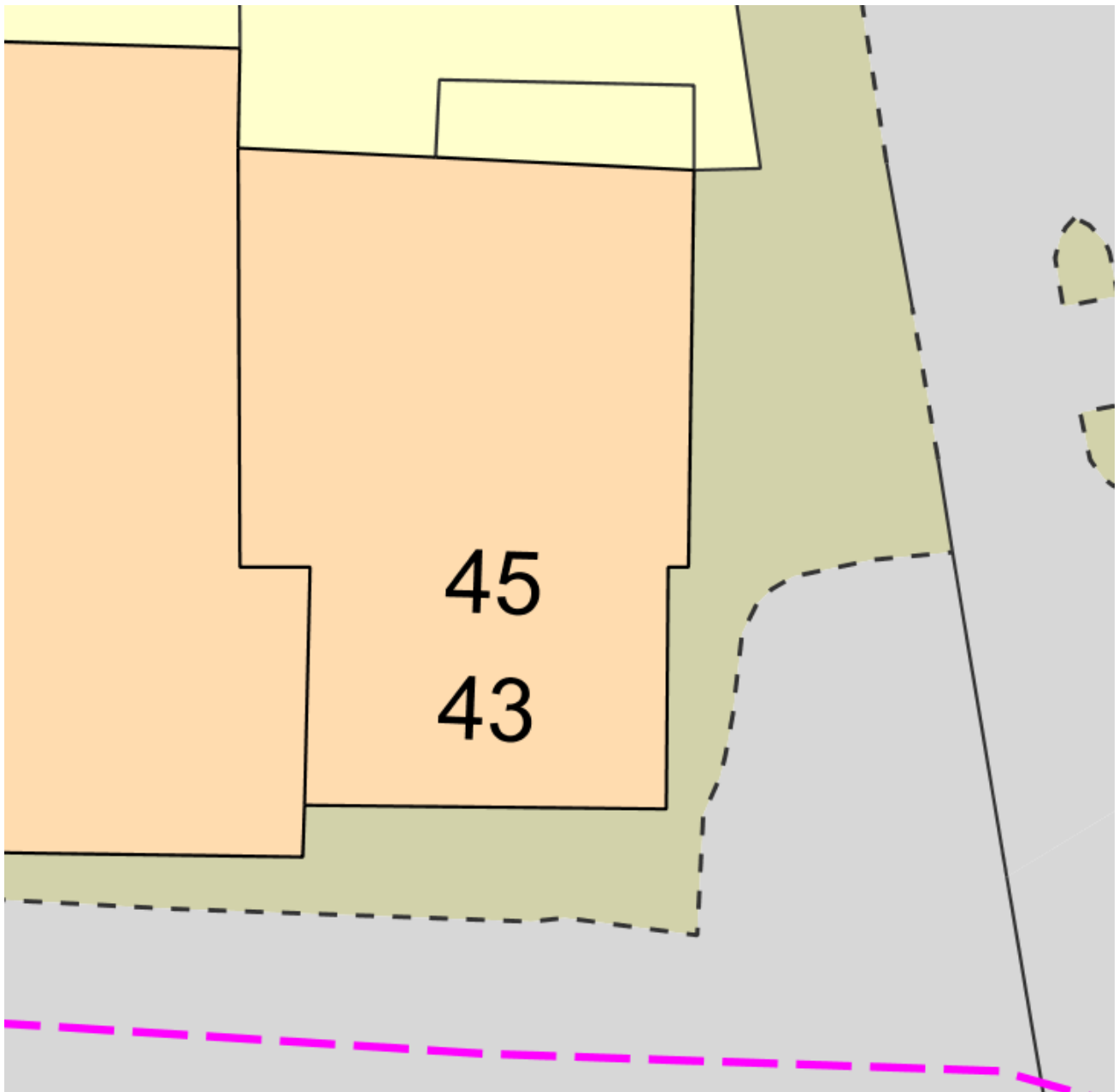

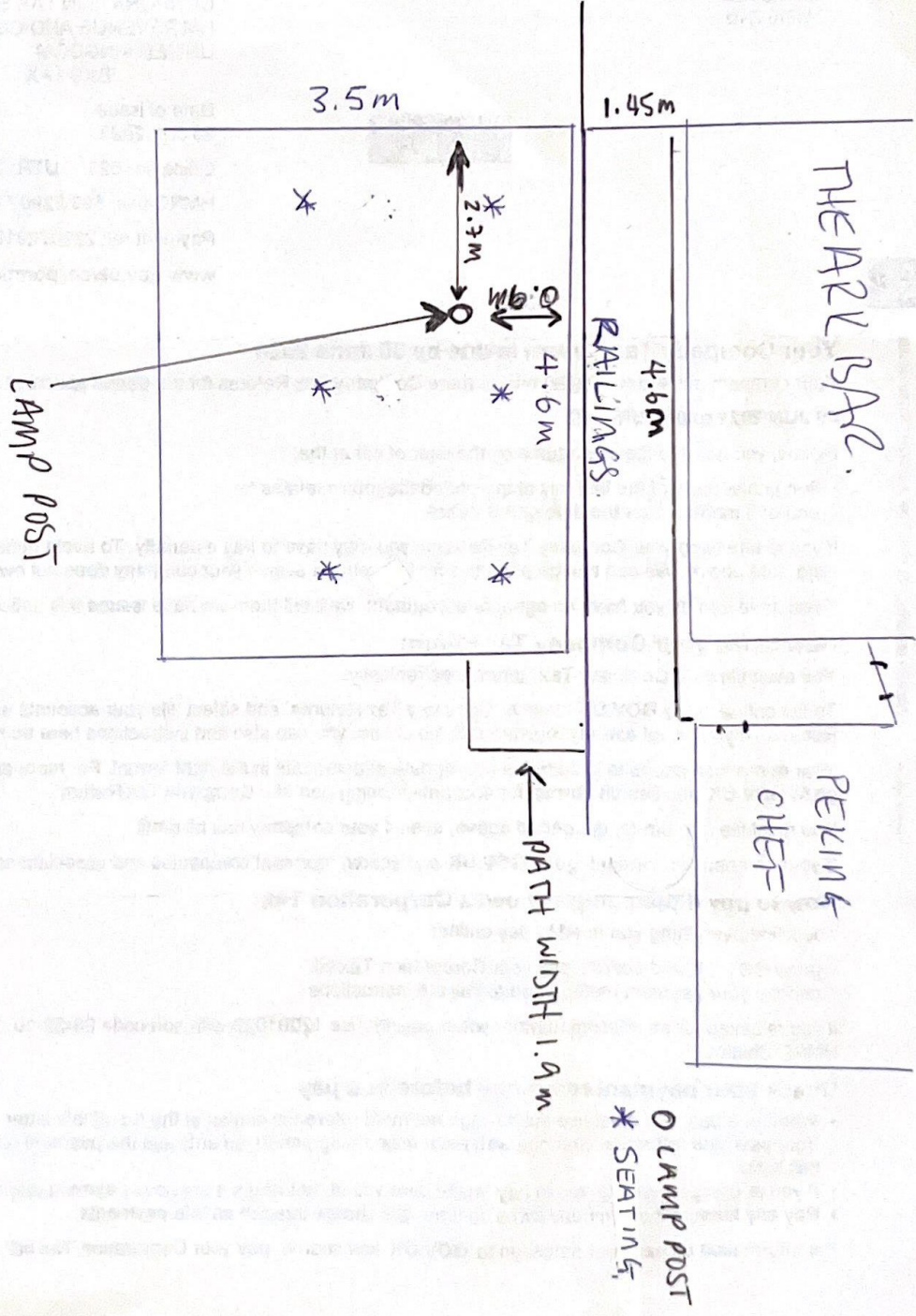
