01. The proposed development, by virtue of its layout, appearance and building style would fail to integrate, respect or complement the character of the area. The proposal by virtue of its design would result in a visually incongruous form of development within the surrounding area. The roof form, with multiple competing gables, results in an unbalance design that would be overly top-heavy and its appearance would be uncharacteristic of the area. As such the proposal is of poor design that fails to improve the character, function and quality of the area. As such it is contrary to Policies E1 and COM2 of the Test Valley Borough Revised Local Plan (2016).

02. Due to the position of the proposal within the plot, the small plot size relative to built form and the requirement to provide two parking spaces, the development fails to deliver any landscape features of merit which would enable the proposal to positively integrate into the landscape character of the area. The development would introduce an overly hard form of development which would be out of keeping with the character of the area and would have a detrimental impact on the appearance of the immediate area and the verdant and spacious landscape character of the area. As such it is contrary to Policies E2 and COM2 of the Test Valley Borough Revised Local Plan (2016).

03. No information has been provided in relation to waste water created from the proposed development and that the development would achieve nutrient neutrality. The proposal would have a likely significant effect on the internationally protected sites in the Solent, specifically the Solent Maritime SAC, Solent and Southampton Water SPA & Ramsar site, the Portsmouth Harbour SPA & Ramsar site and the Solent and Dorset SPA, and would cause harm to the Solent's protected habitats and bird species as a result. The development is not in accordance with Policies COM2, E5 or E8 of the Test Valley Borough Revised Local Plan 2016.
