O1. The proposal would be located in a position where views would be readily available from multiple locations within the immediate area. The scale is considered to dominate the principal elevation of the property to the point where the symmetry which contributes positively to the dwelling is eroded. The proposed development also lacks subservience to its host and is considered out of scale, protruding forward of the principal elevation which would result in the breaking of the existing building line. This protrusion is also considered to result in a built form which juxtaposes awkwardly against its host. There are also no extensions of this scale in this location on any buildings within the immediate area, and as such the resultant development would look incongruous within the street scene. As such, the proposal is not considered to integrate, complement or respect the character of the area in which the development would be located, contrary to Policy COM2 and E1 of the Test Valley Borough Revised Local Plan (2016).

Hampshire County Council and its partner Authorities, Southampton City Council, Portsmouth City Council, New Forest National Park Authority and South Downs National Park Authority – are working to produce a partial update to the Hampshire Minerals and Waste Plan up until 2040.

The partial update to the Plan will build upon the currently adopted Hampshire Minerals and Waste Plan (2013), with an updated evidence base on how much minerals the area needs and how much waste it produces, now and up to 2040. Strategic sites are proposed to help meet the need for mineral and waste infrastructure, as well as updated policies on how and where this infrastructure should be delivered. The vision and the policies have also been updated in line with changes to national and local policy, in particular the increased importance of addressing climate change.

The Hampshire Authorities will be inviting comments from consultees and communities on the Draft Plan. The Draft Plan Consultation will begin on **8 November 2022** and will run for 12 weeks, until **31 January 2023**.

Statement of Community Involvement in Planning (SCI) 2022

Test Valley Borough Council has published for public participation its draft Statement of Community Involvement in Planning (SCI) 2022 and is inviting representations between Friday 11 November and Friday 16 December. The purpose of the SCI is to set out the consultation measures that the Council will undertake when consulting on planning policy documents and publicising planning applications.

We are repeating the public consultation process as we became aware that not all consultees received notification of the original consultation. Representations made on the SCI received during the original consultation do not need to be resubmitted. They will be retained and considered in finalising the document.

The SCI complements the Council's broader commitment contained within its Corporate Plan with regards to promoting positive community engagement with local communities, businesses and interest groups. The preparation of an SCI is a legal requirement and once adopted, the Council needs to be consistent with its content.

The Council's current SCI 2017 will reach its five year anniversary of adoption at the end of 2022, a review has been undertaken and an updated draft SCI published for public consultation. The SCI will apply the whole of Test Valley, outside of the New Forest National Park.
