I wanted to give you the full background before sending this email.

TVBC inform me you have the parish responsibilities for rights of way. On behalf of Andover Ramblers and Hampshire County Council we are seeking Andover Town Council agreement on a matter concerning rights of way.

Under the Countryside Act 1968 s 27, HCC have a duty to waymark rights of way where they meet a metalled road. The advantages of such a law in a rural area are obvious. Without such waymarking many people would no know a right of way exists. However, the statute sets no time limit on this duty and it is recognised that this means that some paths remain unsigned. HCC and Ramblers success in generally waymarking to meet the act has been very good.

However, for some urban paths the need to waymark them is questionable. They are mainly tarmacked and it is obvious they are for use by the public. They are identical to footways which require no waymarking. Often there right of way status is simply a carry-over from before developments have taken place. Also, HCC have difficulty in placing waymark posts at the site. They are tarmacked or paved and utility lines can run close to the surface. A good example of such a right of way is the western end of Union Street where it meets the high street.

The Act allows HCC to be relieved of this responsibility if it considers a sign unnecessary and if the local parish council agrees, which is why we are seeking your agreement. The rights of way we are seeking agreement to are 7, 9, 10A, 24, 25, 30A, 30B, 31A, 31B, 32, 33, 34B, 35, 36A, 38A, 38B, 38C, 38D, 49, 50, 60, 63A, 63B, 66, 69, 501 (see attached map). Of course, if there is a convenient lamppost/telegraph post/traffic sign/barrier etc where the right of way meets the road a waymark will still be put up.

If you do not agree to the proposal, HCC are likely to revert to the 'no time limit' clause. You may therefore wonder why we are bothering and why Andover Ramblers are involved. It is because we undertake a Best Value Performance Indicator (BVPI) inspection/audit of HCC regarding their duties over rights of way maintenance. This is a national standard that they are judged against. A proliferation of rights of way in an urban area can skew the results markedly and give a completely false picture regarding the HCC performance. We would much rather they spent their time clearing path obstructions and repairing rights of way furniture (stiles/gates/bridges etc) than erecting signs that are not needed.

Could I ask you please to put this proposal before Andover Town Council and seek their agreement to it? Perhaps you could let me know when the Council is likely to consider it. If you have any queries, please do not hesitate to contact me.
