- Note loss of green space and amenity.

- The information is incorrect in relation to proximity of footpaths as there is a footpath 30 meters away from the proposed location.
- Can the case Officer clarify the exact location?

Members noted the Speed Indicator Sign (SID) update report.

Members were pleased to see that the previously requested alternative locations had been accepted by Hampshire County Council (HCC). However, it was felt that clarification was required regarding lamp column 38 in Picket Piece, of which HCC have stated that they had no knowledge of a camera already being situated there. Also, clarification was required regarding lamp column 33, which currently had temporary development signage on. Can this be utilised for a SID at a later date once the temporary development signage has been removed?

Officers would investigate and report back at a future meeting.

It was proposed by Councillor C Ecclestone and seconded by Councillor D Coole that it be recommended to accept the alternative locations of the placements of the SIDs, as additional site locations.

A recorded vote was taken as follows:

For: Councillors D Coole, J Coole, C Ecclestone, L Gregori, B Long and R Meyer. Unanimous.

RESOLVED: That it be recommended to accept the alternative locations of the placements of the SIDs, as additional site locations.

Members noted that to date, Councillor Banville and Councillor Long had accepted the invite to form a Speed Indicator Sign working group. It was clarified that the working group would be responsible for the administrative issues, consideration of sub-contractors to move the SIDs and the procedures for downloading data and its usage.

PC 303/19 Design Statement

Members noted that an update was required regarding whether there was enough money in the budget and grant application to cover the costs of printing costs, provision of paperwork to be distributed to members of the Public, hiring of the Time Ring, and a pop-up stall in the Chantry Centre, for the first stage of the Public Consultation.

It was commented that due to the current lockdown, it would be difficult to proceed and it may be better to refer this item to the next Planning Meeting.

A member declared his frustration at the continued delay and suggested that the Chairman and Vice Chairman meet with the Locum Clerk to discuss the way forward in more detail. The Locum Clerk agreed as it would be an ideal opportunity to utilise the meeting to discuss the Neighbourhood Plan as well.

The Chairman also requested the Locum Clerk to ascertain whether a response had been received in relation to the Design Statement grant that he had previously submitted to HCC, as he stated he did not put himself as the main contact on the grant application and so would not have received a response personally. The Chairman confirmed he would forward a copy of the grant application to the Locum Clerk to assist.
