# Introduction from the Town Mayor

I was delighted to be elected as Town Mayor for 2024/25 by fellow Councillors in May 2024. It is an honour and privilege to serve Andover residents, taxpayers and businesses.

Our activities in spring and summer 2024 were overshadowed by a surprise general election called for July. The election brought us a new government with new priorities, although there was no change to our sitting MP in Andover. Applications to government funding for community projects were closed and therefore curtailed our efforts to buy land at Picket Piece for the benefit of the community. However, feedback from the consultation exercise will prove useful as we move into 2025/26.

In June 2024, we delivered the first ever Pride event in Andover, followed by a Jerk Jam festival at the end of August. Both were free events and well attended. I was proud to represent the Town Council at Remembrance Day events in November. For Christmas 2024, we held carols around the Christmas tree, supported by the Andover Town Band. We also extended our Christmas lights display to include Western Avenue, George Yard and Black Swan car parks, as well as adding new Christmas tree lights, all of which survived Storm Bert.

Our financial management remains sound, and the Council is debt free. The External Auditor's Report and Certificate for 2023/24 raised no concerns, nor did the interim audit report for 2024/25. I have been keen to promote our grants funding and for 2024/25, we set the budget at £20,500 and increased it by a further £12,000 during the year. We allocated this to Andover Carnival, 20<sup>th</sup> Andover Guides, Andover Community Engage, Saxon Fields and Artists Way Community Association, More Education's Koala Community Hub, and Unity, with more applications being submitted.

We continued to deliver allotment services to 561 tenants in 533 plots at 9 different sites and considered 179 planning applications and 9 licences. To promote community safety in 2024/25, we added nine new speed indicator locations to the Andover rota and helped fund a new defibrillator in Picket Piece.

Following resignations and casual vacancies late in 2024, we welcomed three new Councillors in 2024/25 by co-option: Councillors Andrew Horsnell (St Mary's), Graham Walters (Millway) and Tony Burley (Millway).

Councillors have worked together to draft a business plan for 2025/27 and acknowledge we can improve our local reputation through good governance, civility and respect. Furthermore, I have contacted key community stakeholders for their views on our proposed business plan and as well as publishing the draft business plan for comment, we held two informal councillors 'tea and biscuits' events to gather

feedback from residents. Our budget for 2025/26 will therefore be supported by an ambitious business plan to put the Andover Community First.

Finally in 2024/25, we have consolidated our staffing structure and reviewed job roles to make sure we can deliver our priorities in the future. I thank our Officers, past and present, for their support, advice and knowledge.

The role of the Allotments Committee is to deliver allotment services to 561 tenants in 533 plots at 9 different sites.

### Report of the Chair:

Throughout 2024/25, the Allotments Committee continued to hold regular meetings and surgeries, and members completed several ad-hoc site visits.

Progress at the new site at Picket 20 has slowed considerably, with staff and councillors making several site visits to meet the developer. The handover of this site was expected to take place in mid-2024 but this was delayed and is now likely to take place in mid-2025. The council continues to work with the developer's legal teams to ensure the site is handed over as soon as possible and is of a high standard when received.

New perimeter fences have been installed at the Admirals Way and Churchill Way allotment sites. The fences at these two sites were identified as those most in need of replacement. This has provided a higher level of security compared to the low and aging chain-link fences that were replaced. The next site to have the fencing replaced will be Old Winton Road. This work will be completed in 2025, once quotes have been received and a contractor is selected.

The water trough at Ox Drove was replaced with a tap to allow tenants to water their plots. A water trough was chosen when the site was built as it presented a greener solution. In practice, the water trough was not used enough to prevent water from becoming stagnant. This information will feed into our new-site requirements to ensure that the issue does not re-occur.

An annual review of rules and regulations took place in 2024/25. The committee also dealt with several rules and regulations change requests from tenants throughout the year, including a request to allow dogs on sites. This was discussed in detail by the committee, and it was unanimously decided to keep the rules as they are.

I would like to end this report by thanking the council staff, along with our team of Wardens for all their hard work throughout the year. Without their tireless work and dedication, the allotments would cease to function. I would also like to thank all the members of the allotments sub-committee for their contributions throughout the year. As with last year special thanks go to Councillor Reynolds, who has continued to go above and beyond to help with the smooth running of all the allotment sites.

### Communications

The Committee has reviewed the appropriate policies, and made sure that they are fit for purpose, and achieve what is needed from them. They are then passed to Full Council for ratification. Over the last year members of the committee have worked with officers to ensure that there is ongoing good communication with external partners. The new website still needs to be developed, and this is something that the committee needs to look at in the coming year.

### Grants

The Committee has had oversight of the Grants Policy and made changes to how the scheme is run and publicised. We have also heard and approved grant applications and been delighted to support a wide range of organisations and events across the year and have given out £29,172.33 in grants.

### **Finance**

Throughout the year the Committee has ensured that everything that is carried out is within budget, and that it is clear where the funding is coming from, and that it is fiscally responsible. We have fed into the Full Council budgeting for 2025/2026 to ensure that the good works carried out by the Committee can continue.

Report of the Chair:

The role of the Planning Committee is to make observations on all planning applications and planning issues for the Andover Town area, Since May 2024 to date, the Planning Committee has considered 179 planning applications and 9 licences.

The Planning Committee has been diligently reviewing all submissions and proposals throughout this term, commenting and objecting where necessary and within our remit. The Planning Committee has highlighted where applications have fallen short and not provided enough information or details to help properly form coherent decisions and commenting. The Planning Committee has also fed back our support for certain proposals which were for the betterment of the town. We have particularly focused on ensuring new homes are future proofed to take into account sustainability.

We have continued to make progress on the Speed Indicator Devices (SIDs) project which contributes towards the safety of Andover's roads. The SIDs are providing additional data which helps to aid better understanding and we intend to increase SID provision.

Test Valley Borough Council (TVBC) is the Planning Authority and makes the final decision on a quasi-judicial basis. We have expanded our relationship with the TVBC planning department and have had additional training sessions with senior officers including Head of Planning and Head of Planning Policy, to better understand and cooperate with TVBC to deliver the best outcomes possible for our residents.

The Planning Committee has contributed on a number of consultations representing the Andover view, including such diverse areas such as hospitals and the local plan for housing. We also carried out one site visit.

The Planning Committee has diligently carried out its duties and responsibilities throughout this term and I am grateful to all Councillors and Officers for their continued support and time, to ensure we are providing the necessary scrutiny for the town and community.

The role of the Policy and Resources Committee is to introduce and review Town Council policy, identify resources to deliver our commitments and prepare the annual budget and precept.

Firstly, I would like to thank the members of this committee, our meetings have been thoughtful and challenging this year and as always, we have questioned the value for money we are delivering as a Council.

The 2024-25 budget was set by us and agreed at full Council. It created a little scope for us to work with. We are pleased to report that as we present this report, we are due to come in roughly in line with what the budget we set last year.

When it came to setting the budget for 2025-26, we had a very constructive meeting and a great discussion around some of the ambitious projects the council is aiming to do this coming year. Some of which are:

- Allotment fencing During 2024, we Council began the replacing the fencing on some of the older allotment sites. This project will continue in 2025.
- Websites the Council is committed to ensuring that we operate a useful and informative website. As such, a small amount of money has been set aside to do this.
- Young and older people services with budgets constraints and cuts being seen across the area, Andover Town Council voted to set aside some money to help support these vital services.
- Election costs we are committed to ensuring that there are suitable funds set aside to cover the projected future costs.

The Policy and Resources Committee has again ensured that the Town Council remains on a stable financial footing. We continue to work with other local authorities to help fund events and services that benefit Andover residents.

# **English Devolution**

Government published its English Devolution White Paper in December 2024, setting out its plans to expedite transferring powers, funding and programmes from Westminster to local areas, thereby empowering local communities. In February 2025, Hampshire County Council was accepted onto the Government's fast track English Devolution Priority Programme, a significant milestone on the path the establishing a combined County authority and potential administrative reorganisation. The next step is for Andover Town Council, along with all Andover residents, is to proactively respond to the government's public consultation on Hampshire and the Solent devolution, which closes in April 2025.

Our business plan for 2025/27 includes opportunities for Andover Town Council to work closely with local stakeholders throughout this process of considerable change and will provide support and communication as well as reducing unnecessary speculation, especially for staff.

For ease of reference, I include at **Appendix B** an updated list of the powers, duties and functions available to a parish council, although Andover Town Council does not currently hold or exercise them all.
