Footpath access should be provided all along Ox Drove.

Objection to traffic exiting onto Ox Drove.

Objection to shutting off Ox Drove, access must remain for garage at end of Ox Drove.

Clarification is required as to whether Ox Drove is a minor road or a rural road and provision should be made accordingly (Ref. 3.5 of Transport Assessment). The Traffic Survey states that Ox Drove to London Road has significant ample capacity for future use, it does not need to be closed off. If road is shut off, all deliveries, tankers etc will have to pass through the new development.
