PC 018/19 Apologies

Apologies were received and accepted from Cllr G Davis and it was noted that Cllr K Farrer had been nominated as his substitute.

PC 019/19 Declarations of Interest

There were no declarations of interest.

PC 020/19 Motions from Councillors

Motion of No Confidence.

Proposed by Cllr C Ecclestone and seconded by Cllr D Coole.

“That this committee has no confidence in the chairmanship of this committee by Cllr Richard Rowles.”

Members discussed the Motion.

Questions were asked as to why the Motion had been brought to the Committee. As part of the discussions Cllr L Banville requested that it be minuted that she would be submitting a complaint to the Monitoring Officer under the Town Council’s Code of Conduct, Part 2, sections 1.1, 1.4, 1.5 and 1.9.

The debate about the Motion was concluded and the Chairman asked for a vote.

A vote was taken, 2 For, 3 Against, 1 Abstention.

The Motion was not carried.

PC 021/19 Minutes
