The gates at Vigo Road Allotment site had not been installed properly when they were erected and it had become evident that they were unstable. The gateposts wouldn't have come out of the ground but they were loose enough to have damaged nearby vehicles or injured people if they had fallen. It had been agreed to effect repairs as a matter of urgency. During the works, other problems were discovered and the costs exceeded the original estimate. Cllrs were asked to bear in mind it estimates were not the same as quotes.

Members were advised of a recent issue at Churchill Way whereby a window at a neighbouring property had been damaged by a small stone, which had been thrown whilst contractors were on site. The cost for replacement was minimal and was split between the Contractor and the Council as the blame could not be attributed. It had been important to show the Council were a "good neighbour" in having the damage replaced quickly.
